



## Father Stuart's Message for December 2017

Dear Friends in Christ:

Several years ago as I traveled to my mother's on Thanksgiving day, I found myself listening to a Christmas story being read on the radio. The story was "The Christmas Box" by Richard Paul Evans. Of course, I began to grumble to myself that I haven't even eaten Thanksgiving dinner yet and here I was listening to a Christmas program. Can't I get through one holiday before having to think about the next one? But I had never heard this story and so I continued to listen.

What really caught my attention in the story was this question. "What was the first gift of Christmas?" I knew how I would answer, but I really wanted to know how the story would answer it. The man being asked the question, after some serious thought, said, "The first gift of Christmas is love." The woman asking the question responded that that was a good beginning, but only a very small part of the answer and that more thought was needed. A lot of time passed. Finally, he got it: "The first gift of Christmas is a child." Wow, I couldn't believe it; a Christmas story that actually pointed us toward the baby Jesus.

I have watched many "Christmas" shows over the years and they all seem to be more about couples falling in love,

families coming together, and Santa Claus coming to visit, and if the baby Jesus is mentioned in any of them, it is only as an aside.

## Charitable IRA Rollover

Are you 70 ½ or older?

The Charitable IRA Rollover is a tax-advantaged way to remember Christ Church and receive tax benefits in return. You can give up to \$100,000 from your IRA directly to a qualified charity like Christ Church without paying income taxes on the money. **This law no longer has an expiration date, so you are free to make annual gifts to the church.**



- ◆ If you have not taken your required minimum distribution for 2017, your IRA gift can satisfy all or part of that requirement.
- ◆ You pay no taxes on the gift and you benefit even if you do not itemize.





## **Christ Church Endowment Fund Board**

**Luncheon, Saturday, January 27, 2018**

**Your Endowment Fund Board is sponsoring a luncheon on January 27, 2018, with Mike Kerr, CEO of The Trustees of the Funds speaking on the new service of Gift Annuity Funds and Planned giving.**

**Giving can be a joy. Supporting the future needs of our church can be gratifying.**

**You want to remember Christ Church but, yet you still need income for day to day needs.**

**A charitable gift annuity may be an excellent way to achieve both goals.**

The Diocese of Virginia has a new way to help you achieve these goals.

With a gift annuity, you make an irrevocable gift of cash or securities in return for quarterly fixed income. After your life-time, 100% of the charitable remainder is made available to the Episcopal Church ministry of your choice. You are able to fund your needs today and remember the church tomorrow.

Thanks to the 2016 efforts of the Trustees of the Funds (TOTF), the church investment arm of the Diocese of the Virginia, Charitable Gift Annuities (CGA) are now available to all parishioners 65 and older. Financial advantages of a CGA are:

- An income tax deduction for a significant portion of your gift in the year the gift is made
- A guaranteed, fixed lifetime income paid by TOTF in quarterly installments
- A portion of the income is tax-free for the majority of your life
- If you fund your annuity with appreciated stock, a portion of the capital gains tax is forgiven
- Expert asset oversight by TOTF and administration by SunTrust Bank
- Your taxable estate will be reduced by the amount of your gift
- After your life time, all remaining assets in your annuity will support Christ Church through the Endowment Fund

TOTF's minimum CGA is \$5,000 and \$100,000 maximum annual funding amount.

Neither the church nor TOTF are providing legal/financial advice and all donors are encouraged to consult with their advisors before proceeding.
