



Father Stuart's Message for January 2018

Taking in Epiphany

We have just celebrated Christmas, or have we? Did you know that for many Orthodox Christians, Christmas day hasn't come yet? We who follow the Gregorian Calendar celebrate Christmas on December 25th, but the Orthodox Church doesn't follow the Gregorian Calendar; instead, they follow the older Julian Calendar which places their Christmas on the 7th of January on our calendar, the day after Epiphany.

I kind of like that. It gives me an excuse to leave up the decorations for yet another 12 days and if people ask "Why?" I can say that I'm now celebrating Orthodox Christmas. But I'm certain I won't do that.

Instead of Christmas, our thoughts now turn to the celebration of Epiphany. The Feast of Epiphany falls each year on January 6th and it commemorates the coming of the Magi as the first manifestation of Christ to the Gentiles or in the Orthodox Church it commemorates the baptism of our Lord. Either way, whether it is the tradition of a star leading the Magi to Christ, or a dove descending upon Jesus at his baptism, we are given insight, an Epiphany, into the true nature of Jesus.

Taking in Epiphany (Cont'd)

Earlier manifestations of God to humanity were called Theophanies. "Theophanies are instances of divine self-revelation in which God manifests himself to humans (the word "theophany," which means "appearance of God," comes from the Greek roots *theo* [God] and *phaino* [to appear]). While theophanies occur in different forms in Scripture, the content of a theophany is always the same. They consistently show God graciously revealing himself and his covenantal promises to his people."

And then another way of speaking of Epiphany is "Revelation" God being revealed to humanity. Three words that are connected to one another, Theophany, Epiphany, and Revelation, whichever word you wish to use to explain it, the God of light and love has entered into our lives to show us just how much He loves us. May the light of Epiphany fill you with God's light and love as revealed to us through His son Christ our Lord.


GLOBAL MARINERS

Soon after we started a group at church “Connecting Threads” (for all types of fiber arts) Fr. Stuart was interested in what type of needlework different members liked to work. Thanks to his support, we have reached into the community to include other members who love to knit, quilt, needlepoint and even weave. One week, Fr. Stuart gave Jean Holt a pattern of a very intricate Christmas Angel that would compliment an already cross-stitched and framed Angel he was given years ago. I was stunned by the beauty and completely impossible task that that pattern indicated and told him that it would be a lifetime project if left to me to do.

So, soon thereafter, one of our group, Susie Loustaunau, showed us her beautiful talent in needlepoint and cross-stitch. She took on the challenge to see if she could do the daunting task. After a year’s worth of troubling health, Susie continued to work on this exquisite piece—the cross-stitches are so tiny, they are difficult to see by just glancing at it. After she completed all of the cross-stitching, Susie sewed on hundreds of beads. This is now a museum-quality masterpiece! Susie said that this project was a lifesaver for her—I say that it was a project filled with love!

The other church members who are regulars in our Connecting Threads group, Susan Neal, Ann Padgett and Jean Holt took over the task of having the final project framed. Since Fr. Stuart’s open house was postponed (where we were to present this piece), and the Loustaunaus would be leaving town soon, we made the presentation at the 10:30 service on Dec. 10th. Fr. Stuart was very surprised and overwhelmed with joy!



Luncheon, Saturday, January 27, 2018

Your Endowment Fund Board is sponsoring a luncheon on January 27, 2018, with Mike Kerr, CEO of The Trustees of the Funds speaking on the new service of Gift Annuity Funds and Planned giving.

Giving can be a joy. Supporting the future needs of our church can be gratifying.

You want to remember Christ Church but, yet you still need income for day to day needs.

A charitable gift annuity may be an excellent way to achieve both goals.

The Diocese of Virginia has a new way to help you achieve these goals.

With a gift annuity, you make an irrevocable gift of cash or securities in return for quarterly fixed income. After your life-time, 100% of the charitable remainder is made available to the Episcopal Church ministry of your choice. You are able to fund your needs today and remember the church tomorrow.

Thanks to the 2016 efforts of the Trustees of the Funds (TOTF), the church investment arm of the Diocese of the Virginia, Charitable Gift Annuities (CGA) are now available to all parishioners 65 and older.

- An income tax deduction for a significant portion of your gift in the year the gift is made
- A guaranteed, fixed lifetime income paid by TOTF in quarterly installments
- A portion of the income is tax-free for the majority of your life
- If you fund your annuity with appreciated stock, a portion of the capital gains tax is forgiven
- Expert asset oversight by TOTF and administration by SunTrust Bank
- Your taxable estate will be reduced by the amount of your gift
- After your life time, all remaining assets in your annuity will support Christ Church through the Endowment Fund

TOTF's minimum CGA is \$5,000 and \$100,000 maximum annual funding amount.

Neither the church nor TOTF are providing legal/financial advice and all donors are encouraged to consult with their advisors before proceeding.






Mary Jo Atterholt (3 years)
